Alderman Williams made a motion to go into closed session, seconded by Alderman Hicks, and with the Aldermen present and voting Aye, the motion carried.


While in closed session, it was determined that an executive session was needed.

Alderman Lauderdale made said motion, seconded by Alderman Miller, and with the Aldermen present and voting Aye, the motion carried.


Alderman Williams made a motion to go back into open session, seconded by Alderman Hicks, and with the Aldermen present and voting Aye, the motion carried.
